ESSER III Plan Community Engagement

In order to solicit more community engagement and input geared towards the ESSER III plan, surveys were developed. The first survey went to our school community including families. The survey was sent on 10/01/2021 via schoolwide webmail. In addition, the survey was advertised in our fall School Advisory Committee meeting. An additional reminder about the survey was sent on 10/04/2021 with the follow up from the School Advisory Committee meeting. Additionally, on 9/30/2021 the survey was sent to all staff including special education administrators, principals/school leaders, teachers and other educators. We received 1,243 responses across the network of schools. In order to allow for all voices and perspectives to be heard, the survey optionally asked for demographic information of the respondents to allow us to know which responses were provided from any of the following groups (percentages are of the total that shared their information):

- White - 37.7%
- Asian - 9.2%
- Black or African American - 8%
- Latino or Hispanic - 21%

Two or More - 9.8%

Other Group or Declined Not to State - 14.3%

The following are those participants that are members of the “underserved students” groups (percentages are of the total that shared their information and respondents were allowed to share all that apply):

Low-Income - 62%

English Learners (families that speak languages other than English) - 19.5%

Person(s) of Color - 45.2%

Foster Youth - 8.7%

Homeless - 8.6%

Person(s) with Disabilities - 34%

Migratory - 6.6%

Using the adult level survey as a guide, a survey was drafted in student friendly language. This survey was sent to students on 10/04/2021.

Finally, California Connections Academy Schools (CalCA) is a network of online charter school, serving multiple counties. As a result, there are no specific community groups, civil rights groups, tribes or advocates that can be consulted with. We did consult with a member of the California Department of Education and received their feedback via a phone conference on 10-8-21.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
